It has been my distinct opportunity to serve as an Alternate Member of the Board of Adjustment since 2001. During this period I estimate I attended well over 50% of the public hearings. This was due to a large number of unfilled positions. The Board often functioned with a quorum-only. This required an Applicant to secure a unanimous vote in their favor.

I am seeking appointment to the Board as a regular member because I am willing to devote the time necessary to become familiar with the cases and visit the sites prior to the hearings. I also actively participate in hearings to question both staff and applicants as to the facts of each case. My experience has taught me to evaluate each case on its own merits without presupposing an outcome.

My experience as an architect has proved to benefit the Board. I am able to address, and sometimes translate, technical issues associated with the cases. I see this as a strong asset in that in numerous cases, a large amount of detailed information must be processed in the case of a relatively short hearing.
