<u>Ken Brown</u>, 112 E. Pecan, representing the applicant, stated the property no longer meets the needs of VIA. The facility is too close to Crossroads facility. He stated they are proposing a mixed use of retail facility for a fast food restaurant with office space use.

Staff stated there were 11 notices mailed out to the surrounding property owners, 0 returned in opposition and 1 returned in favor.
