Approval.

The subject property is currently undeveloped and located at the intersection of IH-35 and Flanders Avenue. There are single-family residential properties located to the east and commercial properties located to the north and south along IH 35. The R-6 C would serve as an extension of the buffer to the north and the south from IH-35.

The following conditions shall apply to the operation of nonresidential conditional uses permitted within any residential district, unless otherwise approved by the City Council: 1. There shall be no exterior display or sign with the exception that a nameplate, not exceeding three (3) square feet in area, may be permitted when attached to the front of the main structure.

2. No construction features shall be permitted which would place the structure out of character with the surrounding neighborhood. In order to conform with the character of the neighborhood, the Urban Design standards listed in 35.342(m) of the Unified Development Code should be considered.

Zoning Request: "R-6" Residential Single Family District to "R-6" C Residential Single

Family District with a Conditional Use for a Professional Office.

Gloria Sanchez, 121 Oak Creek Estates, stated the purpose of this request is to allow the subject property to be used for a professional office for a construction office. She stated they currently have been working out of their home in Poteet. She stated their intent is to construct a small structure on the property with very minimal parking. There would be no storage of any equipment, material or parking of construction trucks. This would simply be for office use only. She stated on occasion they would hold meetings at the facility with their employees. She stated her staff would consist of herself with her architect. She further stated they have agreed with staff conditions and intent to comply with them.

Staff stated there were 22 notices mailed out to the surrounding property owners, 2 returned in opposition and 3 returned in favor.

Everyone present, for and against having been heard and the results of the written notices having been received, the Chairman declared the public hearing closed.
