SUMMARY AND RECOMMENDATIONS

This ordinance authorizes the allocation and expenditure of Human Development Services Funds (HDSF) from various Council Districts in the amount of \$8,000 for the Waste Management of Texas, Incorporated (WMI) College Scholarship Fund. This ordinance also authorizes the execution of a contract with the agency.

Staff recommends the approval of this ordinance.

BACKGROUND INFORMATION

Councilman Barrera (Council District 6) circulated a Council Request for Consideration memo (Attachment A) seeking Human Development Services Fund (HDSF) support for the Waste Management of Texas, Incorporated Annual College Scholarship Program. Allocations were made by Council District 4 (\$3,000) and by Council District 6 (\$5,000) from their respective HDSF budgets for a total amount of \$8,000.

Started in 1999, WMI's Annual College Scholarship Program provides funding for Southside high school graduates to attend college. There are 11 high schools in the program: Burbank, East Central, Harlandale, Highlands, McCollum, Kennedy, John Jay, Sam Houston, Southside, South San and West Campus. WMI expects to serve 33 program participants with these scholarship funds. Many of the recipients come from low-income families, who would not otherwise be able to afford college tuition.

POLICY ANALYSIS

This action is a continuation of existing City Council policy to utilize HDSF to raise the education and skill level of San Antonio residents.

FISCAL IMPACT

This ordinance authorizes the expenditure of Human Development Services Funds from the specified Council Districts and has no additional General Fund impact.

COORDINATION

The Department of Community Initiatives has coordinated the contract and these allocations with the City Attorney's Office, City Clerk's Office, Office of Management and Budget and the offices of Council Districts 4 and 6.

Any individual or business entity seeking a discretionary contract from the city must disclose in connection with a proposal for a discretionary contract all political contributions totaling one hundred dollars (\$100) or more within the past twenty-four (24) months made directly or indirectly to any *current* or *former member* of City Council, any *candidate* for City Council, or to any *political action committee* that contributes to City Council elections, by any individual or business entity whose identity must be disclosed under (1), (2) or (3) above. Indirect contributions by an individual include, but are not limited to, contributions made by the individual's spouse, whether statutory or common-law. Indirect contributions by an entity include, but are not limited to, contributions made through the officers, owners, attorneys, or registered lobbyists of the entity.
