SUMMARY AND RECOMMENDATIONS

This ordinance authorizes Hyatt Resort Hill Country to hold a firework display for Nationwide Financial Services Convention's "Opening Celebration" ceremony on March 16, 2005.

Staff recommends approval of this ordinance.

BACKGROUND INFORMATION

On February 17, 2005, a request for a firework display was received on behalf of Hyatt Resort Hill Country and Alpha Lee Enterprises, Inc. They are requesting an ordinance for permission to hold a firework display for the "Opening Celebration" ceremony of Nationwide Financial Service Convention on their property located at 9800 Hyatt Resort Drive (golf course/driving range). The display is to be held at approximately 8:00 p.m. on March 16, 2005 with no rain date. Security requirements and precautions are included as conditions to the display.

Michael McIntosh, President of Alpha Lee, Inc., obtained and filed all display permits and insurance requirements with the Fire Marshal's Office at 115 Auditorium Circle.

POLICY ANALYSIS

This Fire Department has recommended approval of fireworks permits for special functions when public safety can be assured.

FISCAL IMPACT


A total fee of \$ 450.00 has been paid for the display permit.

COORDINATION


This item has been coordinated with the Fire Department and the Development Services Department.




