Ordinance Requesting the Purchase of Airport Owners and Operators Liability

Insurance

#### **SUMMARY AND RECOMMENDATIONS**

This ordinance authorizes the Interim City Manager or his designee to purchase Airport Owners and Operators General Liability insurance coverage for the City of San Antonio from ACE USA Group through McGriff, Seibels & Williams of Texas, Inc., the City's Broker of Record. The policy is for a one (1) year period beginning 12:01a.m. March 31, 2005 through 12:01 a.m. March 31, 2006, at an annual cost of \$63,263.

Staff recommends the approval of this ordinance.

#### **BACKGROUND INFORMATION**

The above-referenced insurance policy protects the City from large catastrophic claims that may occur at the San Antonio International Airport and Stinson Municipal Airport. The policy pays for those sums that the City may become legally obligated to pay as damages because of bodily injury or property damage arising out of the operations at these two airports. The policy covers all claims that exceed \$10,000.00 per occurrence up to a maximum limit of \$10,000,000.00 each occurrence. Additional coverages included as part of the current and renewal policy are Products-Completed Operations, Malpractice, Personal/Advertising Injury, Blanket Written Contractual Liability, and Hangarkeepers Legal Liability with each having a limit of \$10,000,000.00 per occurrence. These additional coverages broaden the basic policy and therefore are of benefit to the City of San Antonio.

<u>Deductibles</u>: The deductible for each loss occurrence is \$10,000.00. The annual aggregate deductible that the City would pay in a one year period is \$100,000.00.

Request for Proposals Process: A Request for Proposals advertisement was published in the San Antonio Express News newspaper on Sunday, January 16, 2005 and on Sunday, January 23, 2005. The City's Broker of Record also began reviewing coverage needs and marketing this renewal during January and February 2005. Three quotations were received this year; i.e., ACE USA at \$63,263.00, Phoenix Aviation Managers, Inc. at \$85,576.00, and Texas Municipal League (TML) at \$78,998.74. Our Broker of Record sent insurance specifications to the following additional markets for quotes, which all declined: U.S. Specialty, XL

Specialty, U.S. AIG, Global Aerospace, W. Brown & Associates, and the American International Group.

The recommended proposal from ACE USA of \$63,263 is the lowest bid. ACE USA is our current carrier. The renewal quote is a decrease from the current policy term premium of 2%.

#### **POLICY ANALYSIS**

In accordance with the above, the City's Broker of Record recommends placing the Airport Owners and Operators Liability insurance coverage with ACE USA Group. Department of Human Resources concurs with this recommendation.

It is to the benefit of the City of San Antonio that we continue to insure potential legal liability risks inherent in airport operations at the San Antonio International Airport and Stinson Municipal Airport. Purchasing liability insurance for the airports reflects a continuation of past policy.

#### **FISCAL IMPACT**

Funds are appropriated by fiscal year in the Liability Self-Insurance Fund for the purchase of insurance. This ordinance will authorize the encumbrance of \$63,263.00 in the FY 04-05 budget.

#### **COORDINATION**

The Department of Human Resources has coordinated this item with the Finance Department, Aviation Department, and the City Attorney's Office.

Indirect contributions by an entity include, but are not limited to, contributions made through the officers, owners, or registered lobbyists of the entity.
