**SUMMARY AND RECOMMENDATIONS**

This ordinance appropriates funds in the amount of \$30,000 for in-house Design Capital Administrative Costs, \$2,000 for Design Contingency, and \$2,000 for Advertisement and \$1,500 for Environmental Services Department Administrative Charges, for a total ordinance amount of \$35,500, in connection with Linda Lou - Presa to Hackberry, an authorized 2003–2007 General Obligation Drainage Improvement Bond funded project located in Council District 3.

Staff recommends approval of this ordinance.

**BACKGROUND INFORMATION**

This Ordinance authorizes funds in the amount of \$30,000 for design capital administrative costs that will be utilized for City engineering staff to complete the design work and to perform project management duties in connection with the Linda Lou – Presa to Hackberry Project. This ordinance also authorizes \$2,000 for advertising expenses, sets aside \$2,000 for Design Contingency and authorizes \$1,500 to the Environmental Services Department to cover the cost of performing a preliminary environmental assessment.

The \$30,000 design cost was estimated by the Public Works, City Engineer's Office, and is the best estimate based on the time necessary for engineering staff to complete the associated design work. Charges to the project will be based upon expenses actually incurred.

The Linda Lou - Presa to Hackberry project provides for underground drainage improvements necessary to eliminate standing water and for the rehabilitation of the existing pavement and curbs. The Linda Lou storm water drainage system will run along Boxelder Lane and tie into the existing stub-out placed as part of the Metropolitan Planning Organization (MPO) Southcross - Presa to New Braunfels Project.

This project is scheduled for advertising in October 2005. Construction is anticipated to begin in January of 2006 and to be completed by January 2007.

## **POLICY ANALYSIS**

Approval of this ordinance will be a continuation of City Council policy to participate in the development and construction of previously approved 2003-2007 General Obligation Drainage Improvement Bond funded projects.

## **FISCAL IMPACT**

This is a one-time capital improvement expenditure and is included in the FY 05-10 Capital Improvement Budget. Funds in the amount of \$35,500 are available from 2003-2007 General Obligation Drainage Improvement Bond funds and are to be appropriated and made payable as follows:

\$ 30,000.00	payable for Design Capital Administrative Costs
\$ 2,000.00	payable for Design Contingency
\$ 2,000.00	payable for Advertisement expenses
\$ 1,500.00	payable for Environmental Services Administrative Costs




