SUMMARY AND RECOMMENDATIONS

This ordinance appoints the temporary board of directors to the San Antonio Crime Control and Prevention District, and urges the temporary board to give strong consideration to the City Council's priorities in the development of a two-year Crime Control Plan and two-year budget plan; as requested through a Council Consideration Request on April 7, 2005 initiated by Councilman Segovia, District 3.

Staff recommends approval.

BACKGROUND INFORMATION

On March 10, 2005, the City Council passed a resolution effective March 20, 2005, creating the San Antonio Crime Control and Prevention District (SACCPD).

The SACCPD will work on crime reduction programs and the adoption of a proposed local sales and use tax at the rate of 1/8 of one percent to fund said programs. By creating the SACCPD, City Council must name a temporary seven member board of directors within 60 days of March 20, 2005. The temporary board of directors is charged by state law with the responsibility of developing a two-year crime control plan and two-year budget plan.

The City Council, through this ordinance, names the members of the temporary board of directors and also outlines the desire of the City Council as a whole to strongly urge the temporary board to develop a crime control and budget plan that reflects the priorities of the City Council and the citizens of San Antonio.

Pursuant to the Crime Control and Prevention District Act, the City Council appoints the following persons, who reside in the City of San Antonio, to serve as temporary directors of the SACCPD:

The newly created temporary board of directors of the SACCPD is directed to name a chairman within 15 days of this resolution and thereafter develop a two-year crime control plan and two-year budget plan that dedicates all funding to crime control and prevention programs and projects that address both City Council priorities and citizen concerns.

This action will complement the actions taken by the City Council through Resolution #100539, dated March 20, 2005 which created the SACCPD.

A RESOLUTION

NAMING THE TEMPORARY DIRECTORS

OF THE SAN ANTONIO CRIME CONTROL AND PREVENTION DISTRICT

AND URGING THE TEMPORARY DIRECTORS TO GIVE

STRONG CONSIDERATION TO THE CITY COUNCIL'S PRIORITIES 22 -7 PM 2: 32
IN THE DEVELOPMENT OF A TWO YEAR CRIME CONTROL PLAN AND BUDGET

WHEREAS, on March 10, 2005, the San Antonio City Council passed Resolution #100539 effective March 20, 2005, creating the San Antonio Crime Control and Prevention District as a special district created under the Crime Control and Prevention District Act; and

WHEREAS, the San Antonio Crime Control and Prevention District is dedicated to crime reduction programs and the adoption of a proposed local sales and use tax at the rate of 1/8 of one percent; and

WHEREAS, by creating the District, the San Antonio City Council must name a temporary seven member board of directors within 60 days of March 20, 2005; and

WHEREAS, the temporary board of directors is charged by state law with the responsibility of developing a two-year crime control plan and two-year budget plan subject to final approval by the City Council; and

WHEREAS, the temporary board of directors is also charged by state law to give proper notice and hold a public hearing to gather input from the public prior to the adoption of a crime control plan and budget plan; and

WHEREAS, once adoption of a crime control plan and budget plan occurs, the temporary board of directors may order an election for the purpose of allowing voters to vote for or against the proposition no earlier than November 2005;

WHEREAS, state law requires that the temporary board of directors consist of appointees that live within the proposed district; and

WHEREAS, the San Antonio City Council, through this resolution, names the members of the temporary board of directors and also outlines the desire of the City Council as a whole to strongly urge the temporary board to develop a crime control plan and budget plan that reflects the priorities of the City Council and the citizens of San Antonio;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

Section 1

That pursuant to the Crime Control and Prevention District Act, the City Council appoints the following persons, who reside in the city of San Antonio, to serve as temporary directors of the San Antonio Crime Control and Prevention District:

That the newly created temporary board of directors of the San Antonio Crime Control and Prevention District is directed to name a chairman within 15 days of this resolution and thereafter develop a

two-year crime control plan and two-year budget plan that dedicates all funding to crime control and crime prevention programs and projects that address both City Council priorities and citizen concerns:

- additional police officers for specialized units and activities, and neighborhood patrols;
- funding for both capital and specialized equipment to enhance city and park police operations;
- support for community policing and crime prevention programs to both improve and expand program application and effectiveness;
- funding for programs and projects designed to reduce gang and domestic violence;
- funding for elderly and youth-oriented crime prevention initiative.
