

SUMMARY AND RECOMMENDATIONS

This ordinance will waive usage fees incurred by the Buffalo Soldiers Living History and Heritage Association connected to the Heritage Month celebration on weekends in July 2005, for use of the HemisFair Park as directed through a Council Consideration Request (CCR) memorandum sponsored by City Council Members Julian Castro, District 7; Joel Williams, District 2; and, Art Hall, District 8.

BACKGROUND INFORMATION

City Council Members Julian Castro, District 7; Joel Williams, District 2; and, Art Hall, District 8 have submitted a Council Consideration Request (CCR) memorandum to waive park usage fees incurred by the Buffalo Soldiers Living History and Heritage Association for the use of HemisFair Park on weekends in July 2005. Each year, the City of San Antonio has proclaimed July as "Buffalo Soldiers Heritage Month". This year will mark the 5th anniversary of the celebration at HemisFair Park. There will be no admission fees.

The Buffalo Soldiers Living History and Heritage Association, Inc. has requested a fee waiver of usage fees in connection with the use of HemisFair Park. With the information provided by the organization, the following costs are anticipated:

- Rental Fees to be waived: \$210/per day x 10 = \$2,100.00
- Deposit: \$1,500.00 to be paid by Association (refundable)
- Liability Insurance through City's TULIP program: \$175.00 Or may provide their own certificate of liability insurance
- Security is required to be hired by the Association at the ratio of two officers per every 200 people. The officers must be certified peace officers in uniform.
- If electrical set-up is needed, Association must hire its own electrician, with work supervised by Parks and Recreation staff electrician.

POLICY ANALYSIS

The City Council Governance Committee will review this proposed action on Wednesday, May 4, 2005. Staff has reviewed this request in order to assess the financial impact of this event.

FISCAL IMPACT

The total lost revenue to the General Fund will be \$2,100.00.
