## SUMMARY AND RECOMMENDATIONS:

This ordinance will approve the parade permit and authorize the temporary closure of certain streets in connection with the 60 + Mardi Gras Parade being held on Friday, May 20, 2005. The run/walk will assemble at Martin Luther King Park and disband at Comanche Park #2. The route is attached.

Staff recommends approval of this ordinance.

## POLICY ANALYSIS:

This ordinance is consistent with the City policy requiring an ordinance where closures of public streets are requested.

## COORDINATION:


