# **SUMMARY AND RECOMMENDATIONS**

This ordinance will waive all parks and recreation fees, except for the refundable deposit, incurred by the Texas Emancipation Day Commission, Inc. related to the Juneteenth Celebration on June 18, 2005 at Pittman-Sullivan Park, as directed through a Council Consideration Request (CCR) memorandum sponsored by City Council Member Joel Williams, District 2.

#### **BACKGROUND INFORMATION**

City Council Member Joel Williams, District 2, has submitted a Council Consideration Request (CCR) memorandum to waive all parks and recreation fees, except for the refundable deposit, incurred by the Texas Emancipation Day Commission, Inc. associated with the Juneteenth Celebration on June 18, 2005 at Pittman-Sullivan Park. This event is in observance of June 19, 1865, the date thirty months after President Lincoln signed the Emancipation Proclamation and General Gordon Granger of the Federal Occupation Troops issued General Order No. 3 – Emancipation in Galveston Bay, Texas. The schedule will include a celebration at Pittman-Sullivan Park on June 18, 2005 with the understanding that the baseball diamond will not be used. The Pittman-Sullivan Park has been reserved for this date. There will be no admission fees.

The Texas Emancipation Day Commission, Inc. has requested a fee waiver of fees in connection with the use of Pittman-Sullivan Park. With the information provided by the organization, the following costs are anticipated:

- Rental Fees to be waived: Park Pavilion, \$80.00; Special Event Permit, \$1,000.00; Ball Field (Hold), \$180.00
- Deposit: \$1,500.00 to be paid by Commission (refundable)
- Liability Insurance through City's TULIP program: \$175.00

- Security is required to be hired by the Commission at the ratio of two officers per every 200 people. The officers must be certified peace officers in uniform.
- If electrical set-up is needed, Commission must hire its own electrician, with work supervised by Parks and Recreation staff electrician.

### **POLICY ANALYSIS**

The City Council Governance Committee will review this proposed action on Wednesday, May 4, 2005. Staff has reviewed this request in order to assess the financial impact.

#### FISCAL IMPACT

The total lost revenue to the General Fund will be \$1,260.00.

#### **COORDINATION**
