SUMMARY AND RECOMMENDATIONS

This ordinance approves the first amendment to a current Lease Agreement with the YMCA for their use of Panther Springs Park in order to extend the lease term for 15 years to create a remaining term of 27 years and become eligible for Bexar County bond funds.

Staff recommends approval of this ordinance.

BACKGROUND INFORMATION

Ordinance 75887 dated June 4, 1992, authorized a 25-year Lease Agreement between the City of San Antonio and the YMCA, for their use of the 42.318 acre Panther Springs Park. The YMCA facility is known as Mays Family YMCA. Since 1992, the YMCA has constructed multipurpose athletic fields for football, soccer and baseball. They have also constructed two concession buildings with restrooms, bleachers, an administrative office building and parking lots.

The current agreement has 12 years remaining and the City has been approached by the YMCA and Bexar County who have requested that the lease be extended for an additional 15 years to create a remaining term of 27 years. A contract extension will provide a term sufficient for the YMCA to obtain Bexar County bond funding to construct additional improvements at the site. Planned improvements include lights for the soccer/football fields, turf for the infields of the baseball fields, and shade covers for all bleachers. All plans for construction have been reviewed and approved by the Parks and Recreation Department and HDRC. The planned improvements will provide recreational facilities needed for both youth and adult recreation activities.

The revised contract term will expire on April 30, 2032. All other terms and conditions of the original lease will remain the same, including that the lease may be extended for up to two additional successive terms of ten years each.

POLICY ANALYSIS

It is standard practice to amend contracts when deemed advantageous to the City. The contract amendment requires passage of a City ordinance.

FISCAL IMPACT

The YMCA paid a one-time rental payment of \$100.00 to the City when the original lease was approved. This action has no fiscal impact to the City's General Fund.

COORDINATION

The amendment was coordinated with the City Attorney's Office, Bexar County, and the YMCA.

THE LEASE CONTRACT AMENDMENT NO. 1
