SUMMARY AND RECOMMENDATIONS

This ordinance accepts a Gift Deed from VHS San Antonio Partners, L.P., d/b/a Baptist Health System for a right of way dedication consisting of a 0.1243 acre tract of land out of a 12.94 acre tract within New City Block 19221, within the Stone Oak Centre Subdivision Unit 1, located in Council District 9.

Staff recommends the approval of this ordinance.

BACKGROUND INFORMATION

VHS San Antonio Partners, L.P., d/b/a Baptist Health System desires to dedicate to the City of San Antonio, a 0.1243 acre right of way which extends on their property line along Madison Oak Drive and Stone Oak Parkway.

VHS San Antonio Partners, L.P., d/b/a the Baptist Health System has contracted with a private contractor to construct right turn lane improvements on Madison Oak Drive, in order to provide improved traffic flow. All costs of this improvement will be borne by the developer, VHS San Antonio Partners, L.P., d/b/a Baptist Health System, with construction oversight to be conducted by the City of San Antonio.

On March 28, 2005 proposed construction plans were reviewed and approved by the Development Services Engineering Division and there were no objections to the proposed dedication.

POLICY ANALYSIS

Approval of this ordinance will be a continuation of City Council policy to enter into public/private partnerships for infrastructure improvements in order to leverage funds and resources.

FISCAL IMPACT

No funds are to be expended under this ordinance.

COORDINATION

This ordinance was coordinated with the City Attorney's Office and the Development Services Engineering Division.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Acceptance of a Gift Deed from VHS San Antonio Partners, L.P., d/b/a Baptist Health System, it's predecessor in interest or any other predecessor in interest from which it would be appropriate to secure a correction deed, if required, for a right of way dedication consisting of 0.1243 acres of land out of a 12.94 acre tract of land out of New City Block 19221, within the Stone Oak Centre Subdivision, located in Council District 9 appended hereto and incorporated herein for all purposes as Attachment I and as further depicted on a map appended hereto as Attachment II, is hereby authorized.


