

SUMMARY AND RECOMMENDATIONS:

This ordinance will approve the parade permit and authorize the temporary closure of certain streets in connection with the RK Group 5K being held on Thursday, July 7, 2005. The run/walk will assemble and disband at the Alamodome. The route is attached.

POLICY ANALYSIS:

This ordinance is consistent with the City policy requiring an ordinance where closures of public streets are requested.

COORDINATION:


