SUMMARY & RECOMMENDATION

The attached tabulations of bids is hereby submitted for council consideration and action. Annually at this time, bids are requested for various materials, parts and services. This ordinance includes contracts for TexShare database annual membership fee, Texas criminal and traffic law manual, surfcontrol software license and maintenance, John Deere consumer equipment parts & service, Smeal 1250 GPM pumper truck parts & service, and two-part epoxy material.

Many bids are on a firm, non-escalating basis, while others such as petroleum related items and certain other commodities require escalation of prices during the contract period. Generally, bids reflect small increases over recent prior years, but in many cases reflect decreases.

The TexShare program is offered by the Texas State Library and Archives Commission (TSLAC). The TexShare program is comprised of various libraries throughout Texas. If the San Antonio Public Library purchased these databases individually, they would cost approximately \$2,000,000.00. This service is heavily used among library staff and patrons. The San Antonio Public Library, with the assistance of the Alamo Area Library System, tracks database usage in order to determine how well the service is being used. Over 400,000 sessions have been recorded for databases and the Internet activity has resulted in over 700,000 materials being accessed. These databases will be available to patrons using library computers and patrons using home or office computers.
