**SUMMARY AND RECOMMENDATIONS**

This ordinance appropriates funds, authorizes the solicitation of bids and provides for payment for the purchase of two 50-foot traffic poles and two 65-foot traffic poles for an amount not to exceed \$47,000 from 1994 General Obligation Drainage Bonds, in connection with the Goliad Road (Pecan Valley to Military), Phase I project, an authorized 1994 General Obligation Drainage Bond Project, located in Council District 3.

Staff recommends approval of this ordinance.

**BACKGROUND INFORMATION**

The Goliad Road (Pecan Valley to Military) Phase I project provides a typical 44-foot wide, 4 lane street section, curbs, sidewalks, driveway approaches and underground storm drain from just south of the Brooks City-Base property line north to Lasses or less depending on available funds and bid prices. This project is scheduled to be advertised in August 2005 and completed in January 2007.

This ordinance provides the funding to purchase the traffic poles, which will be needed at the beginning of construction on the Goliad Road (Pecan Valley to Military) Phase I project. Since the poles require a long lead-time in receiving them and they are needed at the start of the project, the poles will be purchased by the City and provided to the contractor. The poles to be ordered are:

- 2 – Traffic Signal pole ASM (STL) 1 arm (50 ft) lum
- 2 – Traffic Signal pole ASM (STL) 1 arm (65 ft) lum

**POLICY ANALYSIS**

Approval of this ordinance will be a continuation of City Council policy to complete previously approved 1994 Drainage Bond funded projects.

### **FISCAL IMPACT**

This is a one-time capital improvement expenditure within budget and included in the FY 05-10 Capital Improvement Program Budget. Funds in the amount of \$47,000 are available from 1994 General Obligation Drainage Bond funds.

### **COORDINATION**


This request for ordinance has been coordinated with the Office of Management and Budget and the Finance Department.



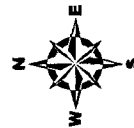
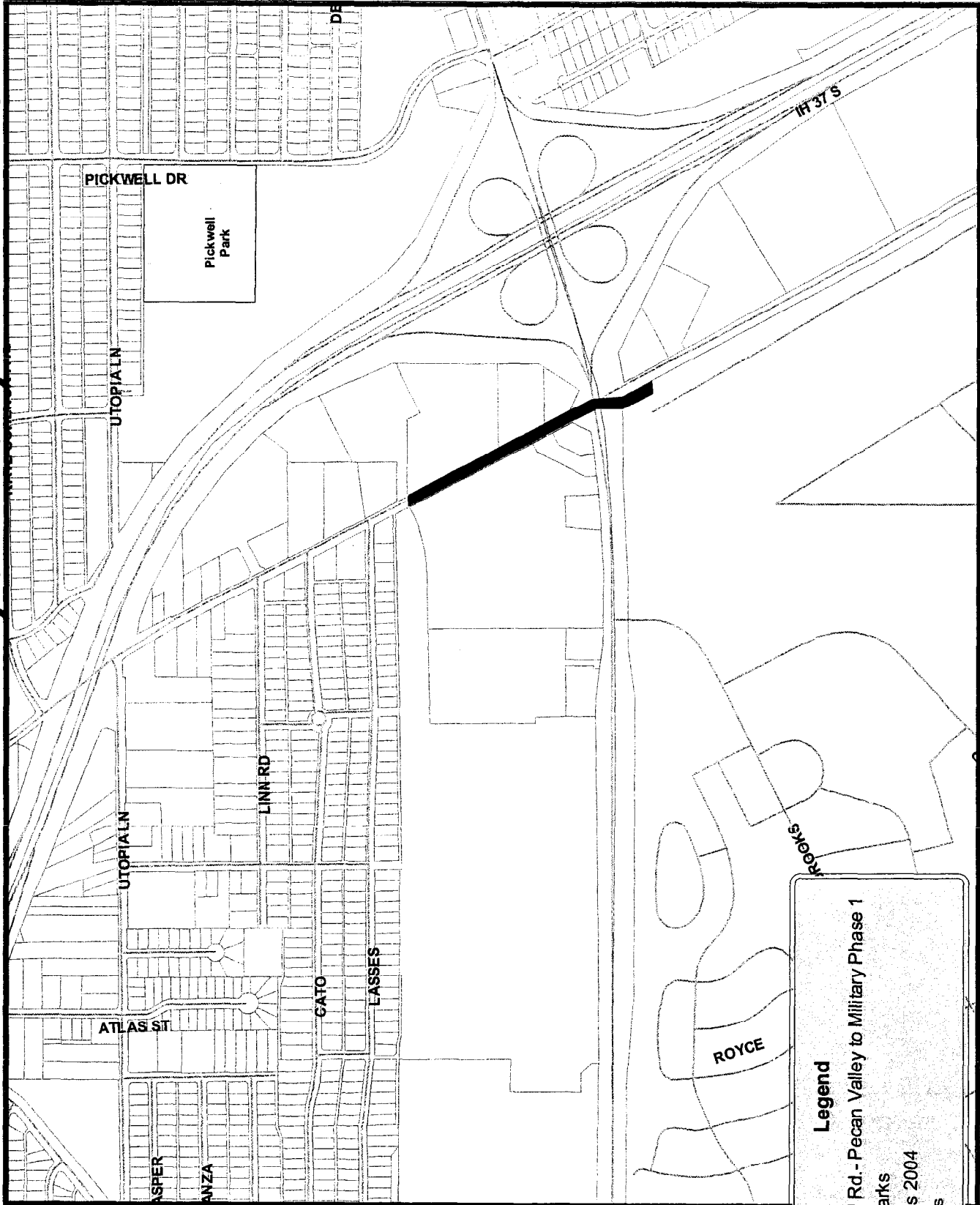
