# **SUMMARY AND RECOMMENDATIONS**

This ordinance authorizes the Interim City Manager to accept and execute contract amendments for two separate contracts with the Texas Commission on Environmental Quality (TCEQ). One amendment provides an additional \$39,167.00 to a contract supporting the San Antonio Metropolitan Health District (SAMHD) Public Center of Environmental Health (PCEH) in the operation and maintenance of several air quality monitors in the local area. In addition, it extends the contract period from August 31, 2005 through December 31, 2005. The second amendment provides an additional \$30,000.00 to a contract supporting the PCEH in the operation and maintenance of two (2) 2.5 micron particulate matter (PM) air monitors that are currently in service plus three (3) additional 2.5 PM monitors to be established later this year. In addition, this amendment from TCEQ extends the contract period from August 31, 2005 through August 31, 2006. This ordinance further revises the program budgets, and revises the personnel complements.

Staff recommends approval.

# **BACKGROUND INFORMATION**

The San Antonio Metropolitan Health District (SAMHD) Public Center for Environmental Health (PCEH) was established to protect the environment of residents in San Antonio. Since air quality has a potential health impact, air monitoring and follow up measures to address the problems identified are important for this objective. The Texas Commission on Environmental Quality (TCEQ), an agency of the State of Texas, has contracted with the City of San Antonio for PCEH to manage two local air monitoring efforts. Through one contract PCEH operates and maintains various air quality monitors. Another contract from TCEQ supports work by PCEH to operate and maintain air particulate matter monitors that trap small air particles known to trigger asthma and other respiratory illnesses in children.

PCEH will oversee and coordinate these operations with TCEQ by collecting air samples and delivering them to the designated analytical laboratory. In addition, PCEH staff will visit each of the continuous air monitors to authenticate functionality on a regular basis.

A total of nine (9) individuals will be involved in the operation of these two programs. Their total hours will be the equivalent of 5.10 FTEs as identified below:

Four (4) of these positions, currently dedicated to other environmental programs, will have additional duties extended to this program (1.10 FTEs). Also, two individuals currently working on the program will expand their duties from a combined partial assistance of 0.70 FTE to a 1.00 FTE. All nine positions will be utilized for monitoring both the established monitors and two new monitors that TCEQ will install.

Both programs require these positions for oversight, coordination of sample gathering, and program accountability (See Attachment I).

# **POLICY ANALYSIS**

This ordinance follows the City practice of utilizing Federal, State and other funds to protect community health.

#### FISCAL IMPACT

This ordinance authorizes two (2) contract amendments between TCEQ and SAMHD as follows:

The contract to operate and maintain the air quality monitors (Contract 582-5-55852) will be extended from TCEQ's fiscal year ending August 31, 2005 through calendar year ending December 31, 2005. An additional \$39,167.00 is provided from TCEQ to support this change. Funding for calendar year 2006 is anticipated.

The contract to operate and maintain the air particulate matter monitors (Contract 582-5-55885) will be extended from August 31, 2005 through August 31, 2006 and three new monitors will be added within the next year. An additional \$30,000.00 will be provided from TCEQ for this change.

With these two amendments, funding for the combined projects will total \$334,167.00. These contract amendments will place no demand on the City General Fund.

#### **COORDINATION**

The City Attorney's Office and the Human Resources Department, Risk Management Division, have reviewed and approved the agreements. The Office of Management and Budget and Finance Department have approved the program budgets. The SAMHD has coordinated these programs with the Departments of Environmental Services and External Relations.

#### SUPPLEMENTARY COMMENTS

Provisions of the Ethics Ordinance do not apply.

#### AN ORDINANCE

AUTHORIZING THE ACCEPTANCE OF TWO CONTRACT **(2)** WITH THE **AMENDMENTS TEXAS COMMISSION** ENVIRONMENTAL QUALITY (TCEQ) AS FOLLOWS: AN AMENDMENT PROVIDING AN ADDITIONAL \$39,167.00 TO SUPPORT THE SAN ANTONIO METROPOLITAN HEALTH DISTRICT (SAMHD) PUBLIC CENTER FOR ENVIRONMENTAL HEALTH (PCEH) IN THE OPERATION AND MAINTENANCE OF AIR MONITORS IN THE SAN ANTONIO, TEXAS AREA AND EXTENDING THE PERIOD FROM AUGUST 31, 2005 THROUGH DECEMBER 31, 2005, AND AN AMENDMENT PROVIDING AN ADDITIONAL \$30,000.00 TO SUPPORT THE SAMHD PCEH IN THE OPERATION AND MAINTENANCE OF THREE (3) PM 2.5 AIR MONITORS THAT TCEQ ESTABLISHED IN THE SAN ANTONIO, TEXAS AREA PLUS TWO (2) ADDITIONAL MONITORS AND EXTENDING THE PERIOD FROM AUGUST 31 2005 THROUGH AUGUST 31, 2006; APPROVING THE EXECUTION OF THE TWO (2) CONTRACT AMENDMENTS WITH TCEO; PROGRAM **BUDGETS**; THE AND REVISING PERSONNEL COMPLEMENTS.

WHEREAS, the City of San Antonio, through the San Antonio Metropolitan Health District (SAMHD), currently provides comprehensive public health services to protect the health of all residents within the jurisdiction of the SAMHD; and

WHEREAS, Ordinance Number 94645 passed and approved September 27, 2001, established SAMHD's Public Center for Environmental Health (PCEH) to address the environmental concerns of community residents and develop strategies for evaluating potential adverse health outcomes; and

WHEREAS, Ordinance Number 99602, passed and approved August 19, 2004, authorized the City of San Antonio to contract with the Texas Commission on Environmental Quality (TCEQ) through two (2) Interagency/Interlocal Category I Agreements to support the PCEH in the operation and maintenance of air monitors previously established in the San Antonio, Texas area along with the operation and maintenance of an additional three (3) PM 2.5 air monitors that TCEQ established in the San Antonio, Texas area for the period September 1, 2004 through August 31, 2005; and

WHEREAS, the Texas Commission on Environmental Quality (TCEQ) has now offered two (2) Interagency/Interlocal Category I Amendments as follows: one amendment provides an additional \$39,167.00 to support the PCEH in the operation and maintenance of air monitors previously established in the San Antonio, Texas area and extends the period from August 31, 2005 through December 31, 2005, and the second amendment provides an additional \$30,000.00 to continue the operation and maintenance of three (3) PM 2.5 air monitors plus two (2) additional monitors that TCEQ established in the San Antonio, Texas area and extends the period from August 31, 2005 through August 31, 2006; and

WHEREAS, it is now necessary to approve the acceptance and execution of the two (2) contract amendments with TCEQ, revise the program budgets, and revise the personnel complements; **NOW THEREFORE**:

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

- **SECTION 1.** The Interim City Manager, or his designee, is authorized to accept Contract Number 582-5-55852, Contract Amendment Number 1, with TCEQ to provide an additional \$39,167.00 to support the PCEH in the operation and maintenance of air monitors in the San Antonio, Texas area and extend the period to December 31, 2005. The Interim City Manager, or his designee, is authorized to execute said contract amendment with TCEQ. A copy of Contract Number 582-5-55852, Contract Amendment Number 1, in substantially correct form, is attached hereto and incorporated herein for all purposes as Attachment III.
- **SECTION 2.** The Interim City Manager, or his designee, is authorized to execute Contract Number 582-5-55885, Contract Amendment Number 1, with TCEQ to provide an additional \$30,000.00 to support the PCEH in the operation and maintenance of three (3) air monitors TCEQ established in the San Antonio, Texas area plus two (2) additional monitors. The Interim City Manager, or his designee, is authorized to execute said contract amendment with TCEQ. A copy of Contract Number 582-5-55885, Contract Amendment Number 1, in substantially correct form, is attached hereto and incorporated herein for all purposes as Attachment IV.
- **SECTION 3.** SAP Fund No. 26008000 has been previously designated for use in accounting by activity for the fiscal transactions of these TCEQ programs. This fund is authorized for use in accordance with these TCEQ agreements.
- **SECTION 4.** The aggregate sum of \$69,167.00 is hereby appropriated in the above-designated fund and the budgets set out in Attachment I and Attachment II are approved and adopted for entry on the City books.
- **SECTION 5.** Payments received from TCEQ for Contract Number 582-5-5852, Amendment Number 1, San Antonio Air Monitoring, are to be deposited into the above-designated fund, Funds Center 3611230000, Cost Center 3611230001, Internal Order 136000000243, SAP GL Number 4501110.
- **SECTION 6.** Payments received from TCEQ for Contract Number 582-5-55885, Amendment Number 1, PM 2.5 Monitoring in San Antonio, are to be deposited into the above-designated fund, Funds Center 3611240000, Cost Center 3611240001, Internal Order 136000000244, SAP GL Number 4501110.
- **SECTION** 7. The eight (8) personnel positions set out in Attachment I are hereby authorized for Cost Center 3611230001, Internal Order 136000000243.
- **SECTION 8.** The four (4) personnel positions set out in Attachment II are hereby authorized for Cost Center 3611240001, Internal Order 136000000244.
- **SECTION 9.** The Director of Finance may, subject to concurrence by the Interim City Manager

or the Interim City Manager's designee, correct allocation to specific internal order numbers, account numbers and fund numbers as necessary to carry out the purpose of this ordinance.

**SECTION 10.** Should either of the two (2) contract amendments be in amounts other than those budgeted for, or should either of the two (2) contract amendments contain terms and conditions different than those currently existing, acceptance of these contract amendments, budgets and corresponding personnel complements will be subject to subsequent City Council ordinance.
