SUMMARY AND RECOMMENDATIONS

This ordinance amends the Traffic Control Device Schedule established by Chapter 19, Section 68 of City Code to include the establishment of new traffic control devices and deletes previous entries from the Schedule in conflict with the current regulations.

Staff recommends approval of this ordinance.

BACKGROUND INFORMATION

This Ordinance is a quarterly request to update the Traffic Control Device Schedule established in Chapter 19, Section 68 of the Code of Ordinances. This schedule reflects both warranted and unwarranted devices. In order to have effective enforcement, any traffic control device needs to be present in this schedule. Warranted devices are those that a traffic engineering study has deemed are appropriate and all design guidelines set forth have been met. Unwarranted devices are those in which city staff has been directed to install even though a traffic engineering study has determined that the device is not needed or does not meet all criteria for installation. The last update to this section was submitted February 17, 2005. Specific Schedules (Titles) included in the ordinance request are:

Cross Street Stop Locations – (16 additional locations) [Schedule C(b)]

School Speed Zones (Mid-block) – (2 additional locations) [Schedule M(a)]

School Speed Zones (Intersection) – (5 additional locations) [Schedule M(a)]

Commercial Loading Zone 30 Minute Limit (2 additional location) [Schedule P(a)]

Passenger Loading Zone – (1 additional locations) [Schedule P(i)]

POLICY ANALYSIS

Approval of this ordinance will enable consistent enforcement of on-street traffic regulations and is a continuation of Council policy to maintain efficient and safe traffic flow.

AN ORDINANCE

AMENDING THE TRAFFIC CONTROL DEVICES SCHEDULES ESTABLISHED BY CHAPTER 19 (TRAFFIC REGULATIONS), ARTICLE III (TRAFFIC CONTROL DEVICES), SECTION 19-68(b) TO INCLUDE CERTAIN ADDITIONS TO THE OFFICIAL TRAFFIC-CONTROL DEVICE SCHEDULE FOR "FULL TRAFFIC SIGNAL LOCATIONS", "ONE-WAY AT ALL TIMES STREET LOCATIONS" SIGNS, "CROSS STREET STOP", YIELD", MAXIMUM SPEED LIMIT" SIGNS, "PARKING PROHIBITED AT ALL TIMES, INCLUDING SUNDAYS AND HOLIDAYS", "STOPPING, STANDING, OR PARKING PROHIBITED 7 AM TO 9 AM AND 2 PM TO 4 PM SCHOOL DAYS ONLY", "SCHOOL ZONES, SCHOOL CROSSWALKS (MID-BLOCK)" SIGNS, "SCHOOL ZONES, (INTERSECTION)" "COMMERCIAL CROSSWALKS SIGNS, LOADING ZONE, 30 MINUTE LIMIT", "PASSENGER LOADING ZONE, 15 MINUTE LIMIT" \mathbf{AND} "MAIL, PICK-UP, 15 MINUTE LIMIT" AUTHORIZING THE PERMANENT INSTALLATION OF SAID DEVICES; DECLARING THEM AS OFFICIAL TRAFFIC CONTROL DEVICES OF THE CITY OF SAN ANTONIO; AND DECLARING VIOLATIONS OF THESE TRAFFIC REGULATIONS, EXCEPT THE CIVIL PARKING VIOLATIONS, TO BE MISDEMEANOR CRIMES PUNISHABLE BY A FINE OF NOT MORE THAN \$200.00, AND DECLARING VIOLATIONS OF THE CIVIL PARKING VIOLATIONS TO BE SUBJECT TO THE ENFORCEMENT PROVISIONS OF CITY CODE SECTION 19-225 (ADMINISTRATIVE ADJUDICATION OF STOPPING, STANDING AND VIOLATIONS), AND ESTABLISHING AN EFFECTIVE DATE OF NO MORE THAN 5 DAYS AFTER PUBLICATION IN ACCORDANCE WITH ARTICLE 2, SECTION 17, OF THE CITY CHARTER.

WHEREAS, Chapter 19 of the City Code requires that all official traffic controls, devices, and regulations be established by separate ordinances; and

WHEREAS, there are certain traffic control devices, parking regulations, and other traffic control regulations at certain locations that have been surveyed by traffic engineers, and determined to be necessary for the public safety; and

WHEREAS, Section 19-68 of the traffic regulations in the City Code require that schedules of the various traffic control devices be maintained and kept updated at the Office of the City Clerk; and

WHEREAS, parking regulations are enforced through civil penalties, while all other traffic violations are misdemeanor crimes; NOW THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 2: All traffic control signs, signals, and other devices listed herein are hereby declared to be official traffic control devices of the City of San Antonio. A violation of any traffic control device or regulation established herein are hereby declared to be Class "C" misdemeanor crimes, and shall be punished by a fine of not less than \$1.00 nor more than \$200.00.

SECTION 3: This ordinance shall become effective on the fifth day after publication in accordance with Article 2, Section 17, of the City Charter but in no manner less than the tenth day after passage by the City Council.
