SUMMARY AND RECOMMENDATIONS

This ordinance accepts the proposal and amends a professional service agreement in an amount not to exceed \$190,428.50, payable to The Arizpe Group, Inc., a SBE/DBE/MBE firm, for professional architectural services, authorizes \$18,340 for miscellaneous contingency expenses, \$13,300 for capital administrative costs, and authorizes \$8,000 for advertising expenses, for a total ordinance amount of \$230,068.50 in connection with the Library Improvements for Bazan Branch Library located at 2200 W. Commerce St. in Council District 5, Carver Branch Library located at 3350 E. Commerce St. in Council District 2, Cody Branch Library located at 11441 Vance Jackson in Council District 8; Cortez Branch Library located at 2803 Hunter Blvd. in Council District 4; Forest Hills Branch Library located at 5245 Ingram Rd. in Council District 7; Johnston Branch Library located at 1023 Ada St. in Council District 3; Memorial Branch Library located at 3222 Culebra Rd. in Council District 5; Pan American Branch Library located at 1122 West Pyron Ave. in Council District 4, and Westfall Branch Library located 6111 Rosedale Court in Council District 1.

As part of the total amendment authorized herein, this ordinance also ratifies the acceptance of previously performed professional services and authorizes payment to The Arizpe Group, Inc in the amount of \$26,992.29 for professional architectural services completed in the preparation of construction documents and design associated with the Cody Library Parking Lot Expansion.

Staff recommends approval of this Ordinance.

BACKGROUND INFORMATION

This ordinance accepts the proposal, amends the professional services agreement with The Arizpe Group, Inc., and authorizes additional compensation in an amount not to exceed \$190,428.50 for professional architectural services in connection with Library Improvements for ten libraries located throughout the city. As part of the not to exceed amount, this ordinance also ratifies payment in the amount of \$26,992.29 for services

previously performed. This ordinance also authorizes \$18,340 for miscellaneous contingency expenses, \$13,300 for capital administrative costs, and authorizes \$8,000 for advertising expenses for a total ordinance amount of \$230,068.50.

This ordinance will provide \$17,580 for initial architectural and assessment services necessary for the Bazan, Carver, Memorial, and Westfall libraries. These services will assist in the determination of the full scope of architectural and engineering services required for complete project development. The anticipated library improvements to these facilities will provide maintenance and repairs that may include HVAC, plumbing, electrical, and roofing upgrades as recommended by the city-wide facility condition analysis study.

This ordinance also provides \$145,856.21 for the preparation of construction documents, for construction administration services at Cody, Cortez, Forest Hills, Johnston, McCreless, and Pan American libraries, and for additional construction administration services associated with the Cody Parking Lot Addition adjacent to the Cody Branch Library. Initial architectural and assessment services for these branch libraries have been completed under the original professional services agreement with The Arizpe Group, Inc., authorized by City Council on June 24, 2004, through Ordinance No. 99433.

POLICY ANALYSIS

Approval of this ordinance will be a continuation of City Council policy to implement previously approved 2003-2007 General Obligation Library Improvement Bond; Community Development Block Grant (CDBG) Funds, and 1989 General Obligation Library System Improvement Bond funded projects.

FISCAL IMPACT

This is a one-time capital improvement expenditure within budget, and included in the FY 05-10 Capital Improvement Program Budget. Funds in the amount of \$135,293.29 are available from 2003-2007 General Obligation Library Improvement Bond funds, \$29,000.21 from 1989 General Obligation Library System Improvement Bonds, and \$65,775.00 from Community Development Block Grant (CDBG) funds for a total of \$230,068.50 authorized payable as follows:

\$ 190,428.50	to The Arizpe Group, Inc. for architectural services
\$ for miscellaneous contingency expenses	
\$ 13,300.00	for capital administrative costs
\$ 8,000.00	for advertising expenses

This item represents a portion of a total estimated project cost of \$3,430,310.

COORDINATION

This request for ordinance has been coordinated with the Finance Department, Office of Management and Budget, the Library Department and the Housing and Community Development Department.
