The subject property is located close to the intersection of Gillette Boulevard and Poteet Jourdanton Freeway. The property to the east and south is zoned for single-family residential, while the property to the north is zoned for commercial use. There are existing single-family residential homes located to the east. O-1 Office District would be more appropriate than C-3 General Commercial District at this location. O-1 would limit the uses to just office, while C-3 would permit more intense commercial uses. The medical facility would serve as a buffer between the freeway and the single-family residential dwellings.

<u>Dusti Clemence</u>, 1203 Medal Lark, applicant, stated she would like to amend her request to "O-1" as recommended by staff. She stated their intent is to develop a medical facility on the subject property.

Staff stated there were 39 notices mailed out to the surrounding property owners, 3 returned in opposition and 3 returned in favor and no response from South Southwest Neighborhood Association.
