#### SUMMARY AND RECOMMENDATIONS

This ordinance appropriates and authorizes compensation in the amount of \$4,250 to Mr. Andre P. Cannon, a resident of San Antonio and a homeowner at 1122 Rice Road, for the removal and replacement of four brick columns in connection with the Rice Reconstruction: W.W. White to Semlinger project, an authorized 1999 General Obligation Street Improvement Bond project located in Council District 2.

Staff recommends approval of this ordinance.

#### **BACKGROUND INFORMATION**

This ordinance will provide compensation to the homeowner for the removal and replacement of four brick columns that collapsed due to dirt erosion and lack of support from retaining walls in connection with the Rice Reconstruction: W.W. White to Semlinger project. Due to the difficulty of matching the new columns with the existing columns, providing compensation to the resident is in the best interest of both parties. An estimate was requested from three contractors and Quality Fence Company, the City's Fence Relocation Contractor, submitted the lowest bid for \$4,250.

The Rice Reconstruction: W. W. White to Semlinger project is a full street reconstruction with sidewalks, curbs, driveways, retaining walls, and wheelchair ramps. The City of San Antonio is performing the work on this project. The project is currently under construction and is anticipated to be completed in September 2005.

#### **POLICY ANALYSIS**

Approval of this ordinance will be a continuation of City Council policy to complete previously approved 1999 General Obligation Street Improvement Bond funded projects.

#### **FISCAL IMPACT**

This is a one-time capital improvement expenditure not within budget in the amount of \$4,250 and is not included in the FY 05-10 Capital Improvement Program Budget. Funds in the amount of \$4,250 are available from 1999 General Obligation Street Improvement Bond and are authorized payable to Mr. Andre P. Cannon of 1122 Rice Road.

#### **COORDINATION**

This request for ordinance has been coordinated with the Office of Management and Budget and the Finance Department.


