



Hopefully I could work with other community organizations, with their help we can attract money as well as young girls. I know how hard it is to get through those pre-teen years. I felt out of place and unattractive especially as a young black girl in a community filled with blond hair and blue eyes. I had people at my church that helped me through that time and told me I was beautiful. Not all girls get that from their close circles of family and friends. Statistics show that most teens that get in trouble (i.e. teen pregnancy, drug abuse, and depression) have low self esteem and wish that someone had encouraged them. I just don't want any young San Antonio women to feel that way.




