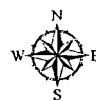


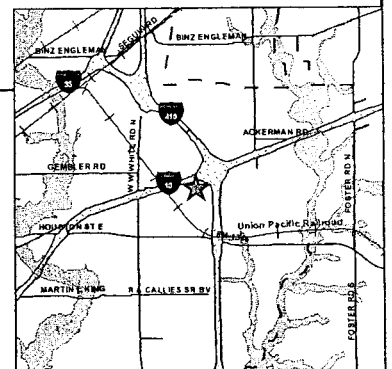

Zoning Request: “R-5” Residential Single Family District to “I-1” General Industrial District.

Abel Guzman, 111925 Starcrest, representing the owner, stated they are requesting and industrial zoning designation. He stated the surrounding uses are currently zoned industrial and feels this request would make the subject property consistent with the surrounding uses. He stated the owner is currently in the platting stages and his intent is to sell the property.
