SUMMARY AND RECOMMENDATIONS

This Ordinance will declare as surplus to the City of San Antonio's needs thirteen (13) farms consisting of 5,905.57 acres in Bexar, Medina and Uvalde Counties controlled by SAWS and authorize SAWS to sell the thirteen (13) farms, less all transferable water rights allowed by State Statute.

Staff recommends approval of this Ordinance.

BACKGROUND INFORMATION

SAWS is requesting to declare as surplus and sell thirteen (13) farms consisting of 5,905.57 acres it controls in Bexar, Medina and Uvalde Counties, as shown on Exhibit "A". The Mallard Farm is the only farm located within Bexar County. SAWS originally acquired the farms to secure water rights associated with the properties. If approved, SAWS will sell the farms and retain all transferable water rights allowed by State Statute.

POLICY ANALYSIS

This action is consistent with the City Code and Ordinances, which require City Council approval for the disposition of any surplus City-owned real property.

FISCAL IMPACT

There will be no financial impact since the City of San Antonio does not control these properties.

COORDINATION

In compliance with City procedures, this request has been canvassed through interested City departments, public utilities and applicable agencies. A Canvassing Checklist is attached for review.

SUPPLEMENTARY COMMENTS

The City of San Antonio's Planning Commission will consider this request at its regular meeting of 5/25/2005 and its finding will be presented to City Council on 6/9/2005.

SAWS is exempt from execution of a Discretionary Contracts Disclosure Statement.


