Applicant: Carlos & Jose Adan

Zoning Request: "R-6" Residential Single Family District to "C-3" Commercial District.

<u>Jose Adan</u>, owner, stated the purpose of this zoning change is to comply with the existing use. He stated he has in operation since 1980 and was not aware of the zoning change that occurred upon being annexed in 1975. He further stated he is agreeable to a "C-3R".

Richard Byrd, 7450 Meadow Breeze, President of Meadow Village Neighborhood Association stated he would like to express their support. He stated he has been in contact with the Lackland Terrace and Cable Westwood Neighborhood Association who are also in support of this request.

Staff stated there were 12 notices mailed out to the surrounding property owners, 0 returned in opposition and 2 returned in favor and no response from Lackland Terrace, Cable Westwood and Meadow Village Neighborhood Association.
