#### **SUMMARY AND RECOMMENDATIONS**

This ordinance appropriates funds in the amount of \$13,800 for fee simple title to three (3) parcels of certain privately owned real property and other miscellaneous expenses associated with the Culebra Drainage #58F, Phase 2A project, an authorized Community Development Block Grant (CDBG) project, located in Council District 7. This ordinance authorizes City staff to acquire these properties at fair market value by negotiation or condemnation, if necessary.

Staff recommends the approval of this ordinance.

#### **BACKGROUND INFORMATION**

There are three (3) parcels to acquire in this project. The scope of work provides for improvement of 4,000 feet of Zarzamora Creek, from Rubidoux to Culebra Road with necessary utility improvements. This project is funded through construction and is currently under design. Project construction is anticipated to begin in January 2006 and be completed in January 2007.

#### **POLICY ANALYSIS**

Approval of this ordinance will be a continuation of City Council policy to complete previously approved Capital Improvement Projects.

#### FISCAL IMPACT

This is a one-time capital improvement expenditure within budget and included in the FY06-FY11 Capital Improvement Program Budget. Funds in the amount of \$13,800 are available from Community Development Block Grant funds and are authorized to be appropriated for Right of Way acquisition related expenditures.

#### **COORDINATION**

This ordinance was coordinated with the City Attorney's Office, the Finance Department, the Office of Housing and Community development, and the Office of Management and Budget.


