Applicant: Joseph N. Barfield

Zoning Request: "R-5" Residential Single Family District to "R-5" CD (Bed and Breakfast)

Residential Single Family District with a Condition Use for a Bed and

Breakfast.

<u>Joseph Barfield</u>, 606 Jackson Keller, owner, stated the purpose of this zoning change is to allow for a bed and breakfast on the subject property. He stated he would only have 1 guest bedroom. There would be no enhancements to the property as there is plenty room for this operation. He stated they live in the cul-de-sac therefore he feels the parking issues have been addressed. He has visited with his neighbors to present his proposal who are in support of this operation.

FAVOR

<u>Keith Bryan</u>, 359 Ave Maria, stated he has been in contact with Mr. Barfield and is in support of this request. He stated Mr. Barfield has been a very good neighbor and feels this would be a plus for their neighborhood.

Mary Alice Ramsey, 125 Ave Maria, President of North Shearer Hills Neighborhood Association, stated Mr. Barfield has presented his proposal to them and they are in support of this change. She stated Mr. Barfield has been a very good neighbor and does not feel his intent would pose a threat to the community.

Staff stated there were 30 notices mailed out to the surrounding property owners, 3 returned in opposition and 21 returned in favor and North Shearer Hills Neighborhood Association is in favor.

Everyone present, for and against having been heard and the results of the written notices having been received, the Chairman declared the public hearing closed.
