"C-3" commercial district would bring the current use as a lawnmower repair shop into compliance. The shop has been in operation for roughly one month and does not have a certificate of occupancy. This zoning change would be appropriate at this location.

<u>Herbert Lee</u>, 6538 Thunderbird Drive, stated they currently have been operating a Thrift Shop on the subject property for approximately 16 years and was unaware they were improperly zoned. He stated the purpose of this request is to continue his operation.

Staff stated there were 34 notices mailed out to the surrounding property owners, 0 returned in opposition and 6 returned in favor and no response from Artesia Community Guild.

Everyone present, for and against having been heard and the results of the written notices having been received, the Chairman declared the public hearing closed.
