### **SUMMARY AND RECOMMENDATION**

This Ordinance will authorize a ten (10) year term License Agreement to the Northeast Independent School District to install fiber cable over and across Broadway Ave., between Sommers Dr. and Fox Hollow, located in Council District 10, for a total consideration of \$5,000.00.

Staff recommends approval of this Ordinance.

### **BACKGROUND INFORMATION**

Petitioner is requesting a license to install fiber cable over and across Broadway Ave., between Sommers Dr. and Fox Hollow, as shown on attached Exhibit "A". The fiber cable crossing will allow the Northeast Independent School District to link the Academy of Creative Education facility to the Regency Pace Elementary School. This link will provide for faster and more reliable communication within the school complex, located in Council District 10.

### **POLICY ANALYSIS**

This action is consistent with the City Code and Ordinances which require City Council approval for any private use of property owned or controlled by the City.

### **FISCAL IMPACT**

The City will collect \$5,000.00 for this license to use Public Right of Way.

### **COORDINATION**

In compliance with City procedures, this request has been canvassed through interested City departments, public utilities and applicable agencies. A Canvassing Checklist and an executed Letter of Agreement, by which the petitioner agrees with all conditions imposed through this canvassing, are attached for review.



Dear Mr. Emilienburg:

With reference to the captioned project, please be advised that the City of San Antonio has now completed the canvassing process and will recommend approval of your request subject to the following conditions:

### **DEPARTMENT OF PUBLIC WORKS:**

"Right of Way Management and Street Maintenance Divisions must approve contemplated fiber cable placement"- Storm Water Utility/ Engineering Division.

"Right of Way permit required"-Street Maintenance Division.

### **SAN ANTONIO WATER SYSTEM:**

"Petitioner must agree to reserve a perpetual easement for all existing water and/or sewer facilities and agree to allow perpetual access to any such utilities for inspection, operational and maintenance purposes or may seek the relocation of the facilities with the express permission and coordination with the San Antonio Water System and at the sole expense of the petitioner."

#### **CITY PUBLIC SERVICE:**

"Northeast Independent School District (NEISD) must sign a pole license agreement with CPS Energy and apply for a pole contacts per agreement." (Jesse Lopez 353-4381)

"Gas main and services must be located to ensure they are not disturbed during construction."

Additionally, the fee established for this License Agreement is \$5,000.00 for a 10-year term. This license fee is due and payable to the City of San Antonio prior to City Council consideration. If for some reason the license is not approved by City Council, the license fee will

be returned to the petitioner. Also, a Certificate of Insurance must be provided and the City of San Antonio must be formally released from any and all liabilities, which may be incurred in connection with this request.

If you concur with the above mentioned conditions, including the payment of the fee established for this encroachment, please countersign this letter in the space provided below and return to the undersigned. Upon receipt of this signed Letter of Agreement, and the Certificate of Insurance we will continue processing your request.

This Letter of Agreement is being offered by the City of San Antonio only to the above named petitioner and will expire thirty (30) days after the date of issuance unless a specific extension is requested by the petitioner and granted by the City.

The purpose of the Interlocal Cooperation Act is to authorize political subdivisions to contract together for functions that they would ordinarily assume on an individual basis. The statute allows education based political subdivisions to join together in a pool to purchase coverage for their property and liability exposures, as well as claims administration and loss control services. The Fund modified self-funded plan was set up, through the By-laws of the Fund, specifically for education based political subdivisions and does not allow for other entities to be named as additional insureds, nor are we able to provide certificates of insurance.
