SUBJECT: Selection of On-Call Professional Firms for Park Design Projects
DATE: December 15, 2005

SUMMARY AND RECOMMENDATIONS

This ordinance selects various professional services companies to perform on-call architectural services, civil engineering services, electrical engineering services, landscape architectural services, and land surveying services for in-house and small park design projects; and authorizes execution of one year contracts with an option for three additional one year renewals.

Staff recommends approval of this ordinance.

BACKGROUND INFORMATION

The use of on-call professional services will assist the Parks and Recreation Department's design staff in the completion of design work on capital improvement projects. Firms will be utilized on a rotation basis, as services are needed, for in-house and small design projects. By having on-call consultants available, design work will proceed more quickly due to reducing the number of weeks devoted to consultant selection procedures for each project. Disciplines that will be contracted include architecture, civil engineering, electrical engineering, landscape architecture, and land surveying.

The firms will provide on-call professional services for a period of one year with an option for three additional one year renewals subject to approval of the Director of Parks and Recreation. Fees for services are estimated to range from \$500.00 to \$25,000.00 per project. Once a project is identified and a proposal for services is received, City Council action will be requested to allocate appropriate funding, as needed.

Previous on-call contracts for the five professional disciplines were approved in October 2003. The firms completed the initial year of their contracts and an extension of one year was requested by the Director of Parks and Recreation. Although the contracts allowed another one year extension, several firms had merged, changed functions, or could no longer do the work, and the decision was made to initiate the RFQ and consultant selection process.

Firms have been selected through the City's consultant selection process.

For **Architectural Services**, Debra J. Dockery Architects, P.C., SBE/WBE; Independent Design, SBE/DBE/MBE; and Nored Shearer Architects, SBE/WBE have been selected.

For **Civil Engineering Services**, K. M. Ng & Associates, Inc., SBE/DBE/MBE; Bain Medina Bain, Inc., SBE/WBE/DBE; and Jaster Quintanilla S.A., LLP, SBE/MBE have been selected.

For **Electrical Engineering Services**, Joshua Engineering Group, SBE/MBE; CNG Engineering, SBE/MBE/AABE; and Alderson & Associates, Inc., SBE have been selected.

For **Landscape Architectural Services**, Beaty & Partners Architects, Inc., SBE; Gould Evans Associates; and TBG Partners have been selected.

For **Land Surveying Services**, Vickrey & Associates, Inc., SBE/DBE/WBE; Poznecki-Camarillo, SBE/MBE; and Unitech Consulting Engineering, Inc., SBE/DBE/MBE/WBE have been selected.

POLICY ANALYSIS

The consultants were chosen in accordance with the City's consultant selection procedures.

FISCAL IMPACT

Funding for the consultants will vary depending on individual projects. Funding will be predominately from Bond and CDBG sources. Once a particular project is identified and a proposal for services is received, additional City Council action may be required to appropriate funding.

COORDINATION

This process has been coordinated with the Public Works Department.
