#### **SUMMARY AND RECOMMENDATIONS**

This ordinance authorizes the City Manager or her designated representative to accept a \$120,000 supplemental grant for the San Antonio HIDTA Initiative from the Office of National Drug Control Policy (ONDCP). The amount of the supplemental grant will be added to the current project. The revised total budget will be \$2,153,568. The grant period is from January 1, 2004 through December 31, 2005.

Staff recommends approval.

#### **BACKGROUND INFORMATION**

This supplemental grant increases the eighth year funding of the San Antonio HIDTA Initiative. The funding for this grant was originally authorized by City Ordinance No. 99086, dated April 15, 2004. The grant period is from January 1, 2004 to December 31, 2005. The original grant award amount was \$2,033,568.

This supplemental award provides an additional \$120,000 for the Accelerated Arrest Program. The program targets the street-to-mid-level drug dealers in the San Antonio area. The funds will be used to purchase drugs during narcotics investigations and for payment of information leading to the arrest of the drug dealers. The program goal is to decrease the number of drug dealers in the community and reduce the drug crime.

### **POLICY ANALYSIS**

This ordinance continues City Council's policy of seeking intergovernmental financial assistance for City crime prevention and enforcement programs addressing drug crime activity. This program will enhance the City's efforts in dealing with narcotics trafficking.

### **FISCAL IMPACT**

The amount of the supplemental grant is \$120,000. If the supplemental grant is approved, no General Fund cash match is required. The amount of the supplemental grant will be added to the current project. The total revised budget is \$2,153,568.

## **COORDINATION**

This ordinance request has been coordinated with the Finance Department, City Attorney's Office, and the Office of Management & Budget.
