(ONDCP) High Intensity Drug Trafficking Area (HIDTA) Supplemental Grant.

## SUMMARY AND RECOMMENDATIONS

This ordinance authorizes the City Manager, or her designated representative, to accept an Office of National Drug Control Policy (ONDCP) High Intensity Drug Trafficking Area (HIDTA) Supplemental Grants in the amount of \$165,628. The amount of the supplemental grants will be added to the current project. The revised total budget will be \$2,243,775. The grant period is January 1, 2005 to December 31, 2005.

Staff recommends approval.

#### **BACKGROUND INFORMATION**

These supplemental grants increase the ninth year funding of the San Antonio HIDTA Initiative. The funding for this grant was originally authorized by City Ordinance No. 100893, dated May 19, 2005. The grant period is from January 1, 2005 to December 31, 2005. Due to the late timing in which these supplemental grants were awarded the grant period will be extended to allow time to expend the funds. The original grant award amount was \$2,078,147.

These supplemental awards will provide an additional \$165,628 for the 2005 San Antonio HIDTA Initiative. The funds will be used for overtime for drug investigations, travel connected to drug investigations, facility lease, office supplies, and to purchase drugs during narcotics investigations and for payment of information leading to the arrest of the drug dealers.

## **POLICY ANALYSIS**

This ordinance continues City Council's policy of seeking intergovernmental financial assistance for crime prevention and enforcement programs addressing drug crime activity. This program will enhance the city's efforts in dealing with narcotics trafficking.

#### **FISCAL IMPACT**

The amount of the supplement grants total \$165,628. If the supplemental grants are approved, no General Fund cash match is required. The amount of the supplemental grants will be added to the current project. The total revised budget is \$2,243,775.

## **COORDINATION**

This ordinance request has been coordinated with the Finance Department, the City Attorney's Office, and the Office of Management and Budget.
