SUMMARY AND RECOMMENDATIONS

The purpose of this item is to appoint members to the Conservation Advisory Board (CAB).

BACKGROUND

On May 6, 2000, voters approved Proposition 3: \$20 million to create linear parks along the Salado and Leon Creeks and \$45 million to purchase 10,000 acres of sensitive land over the Edwards Aquifer. On May 7, 2005, voters approved Proposition No. 1, the Edwards Aquifer Protection Venue Project, which continues the City's program of protecting the Edwards Aquifer. In addition, Proposition No. 2, the Parks Development and Expansion Venue Project, was also approved. As a result, Ordinance No. 100985 was approved on June 2, 2005 which expanded the composition of the CAB, and revised its purpose. The City Council also appointed the Director of the Parks and Recreation Department (or his designee) to serve for so long as he holds his City position, as an ex-officio member of the Board with all membership rights of other appointees.

POLICY ANALYSIS

The CAB is composed of eleven (11) members. Each of the following agencies shall be asked to nominate a representative to be appointed to the Board:

- Texas Parks and Wildlife
- Edwards Aquifer Authority
- San Antonio Water System
- San Antonio River Authority
- City of San Antonio Parks and Recreation Advisory Board
- The Economic Development Foundation
- U.S. Geological Survey
- Natural Resources Conservation Service

In addition to these members, City Council is to appoint two (2) board members from counties that will be affected by this program.

The Board is charged with providing input and advice to staff and the City Council regarding the acquisition of sensitive land over the Edwards Aquifer acquired pursuant to the Parks Development and Expansion Venue Project, and pursuant to the Edwards Aquifer Protection Venue Project, and the appropriate development and stewardship of such land. The Board is also charged with monitoring conservation easements acquired under the Edwards Aquifer Protection Venue Project.

This Ordinance will appoint the following members:

- A) Monica Jeannie Rodriguez (category: San Antonio Economic Development Foundation)
- B) Deirdre E. Hisler (category: Texas Parks & Wildlife)
- C) James L. Blair (category: San Antonio River Authority)
- D) Scott Halty (category: San Antonio Water System)
- E) Bonnie Conner (category: Parks and Recreation Advisory Board)
- F) Robert Potts (category: Edwards Aquifer Authority)

Terms of office shall expire May 31, 2007.

COORDINATION

This Ordinance has been coordinated with the City Manager's Office, Parks and Recreation Department, and the City Attorney's Office. Staff also coordinated with other relevant City Departments.

FINANCIAL IMPACT

There is no financial impact to the general fund.


