SUMMARY AND RECOMMENDATIONS

This ordinance approves the Assignment of an eight (8) year El Mercado Lease Agreement from Antonio Mares d/b/a "Mares Imports" to Maria Robledo d/b/a "Memories of Mexico" for the use of approximately 800 square feet in Stall E-4 in the Market Square El Mercado in City Council District 1. In addition, the agreement is amended to reflect current lease terms and conditions.

Staff recommends approval of this ordinance.

BACKGROUND INFORMATION

On May 18, 2000, the City Council approved thirty-four (34) lease agreements in El Mercado, located at 514 W. Commerce in City Council District 1 in Market Square. One agreement was with Mr. Antonio Mares d/b/a "Mares Imports", a sole proprietorship. This agreement was for lease of stall E-4 with approximately 800 square feet of space used for commercial retail purposes. Mr. Mares has requested the City to grant an assignment of his current lease to Ms. Maria Robledo d/b/a "Memories of Mexico", a sole proprietorship.

Mr. Mares has maintained his lease account with the City in good standing and Ms. Robledo has provided the Parks and Recreation Department with financial information and personal references. Ms. Robledo has an established credit history and also owns "Maria's Imports" which is located in stall E-2 in El Mercado, which she has operated in compliance with her lease agreement.

Ms. Robledo will take over the lease payments and use of the space after approval by City Council. Term will be from February 1, 2006 through December 31, 2007. She will be required to pay utility costs and garbage collection fees, abide by use clauses and minimum hours of operation, provide for all improvements and maintenance of the leased space, and provide insurance levels specified by the City's Risk Manager as set forth in the original lease agreement.

The lease agreement is amended to update lease language to include more current provisions regarding operation of the business, such as an "Owner Presence" requirement and limiting events of default by tenant.

POLICY ANALYSIS

It is the long-standing policy of the City to lease public property in El Mercado for retail sales purposes, under regulations established in Chapter 32, Article II of the City Code. The assignment of a lease agreement requires passage of a City ordinance.

FISCAL IMPACT

Ms. Robledo will continue payments according to the original lease agreement, in which an eight (8) year rental rate schedule was established. The year 7 (beginning January 1, 2006) rate is \$1.42 per square foot per month or \$1,136.00 per month. This will increase to a rental rate of \$1.45 per square foot per month, or \$1,160.00 per month, in the last year of the lease agreement (beginning January 1, 2007). Anticipated calendar year revenues are:

February 1, 2006 – December 31, 2006: \$12,496.00 January 1, 2007 – December 31, 2007: \$13,920.00

The assignment application required a fee of \$1,000.00, which has been paid by Ms. Robledo and deposited into the City's General Fund.

COORDINATION

This assignment was coordinated with the City Attorney's Office, Risk Management and the Department of Asset Management.
