SUMMARY AND RECOMMENDATIONS

This ordinance authorizes the acceptance and appropriation of a special initiatives/disaster relief grant from the Texas Commission for the Arts (TCA) to support youth programs produced via collaboration between two local arts agencies: Arts Teach (Arts San Antonio) and Healing Arts (Boys & Girls Club). The grant is for the sum of \$5,000, and the Office of Cultural Affairs is required to match that amount and appropriate \$5,000 from its budget. Each agency will receive \$5,000.

Staff recommends approval of this ordinance.

BACKGROUND INFORMATION

Due to the disasterous effects of hurricanes Katrina and Rita, and the influx of displaced persons to Texas, the National Endowment for the Arts provided the Texas Commission on the Arts with disaster relief funds. These funds are intended to help agencies better serve the displaced populations living in Texas. Since San Antonio has become home for many Gulf region residents, the Office of Cultural Affairs applied and was awarded this grant to help two local agencies collaborate to produce programs for youth in school districts with a large population of former Gulf Coast residents. The funds will support and implement a collaborative arts program between Arts Teach (Arts San Antonio) and The Healing Arts (Boys & Girls Club) to educate and help children and youth displaced by the hurricanes to cope with their unique circumstances through the theraputic and intrinsic value of arts education. Arts Teach will conduct 65 workshops with approximately 25 children in each. The Healing Arts will conduct 40 weekly workshops/sessions for 10-20 kids in each. The activity will take place in San Antonio during spring and summer 2006.

POLICY ANALYSIS

The TCA grants will continue to augment project support activities funded by the Community and Visitor Facilities Fund and will continue to support The Cultural Collaborative.

FISCAL IMPACT

The TCA grant is for a sum of \$5,000, and requires a \$5,000 match by OCA to be appropriated from its budget. This ordinance authorizes payment of \$5,000 to Arts Teach (Arts San Antonio) and \$5,000 to Healing Arts (Boys & Girls Club). There is no impact to the General Fund.

COORDINATION

The acceptance of the grant has been coordinated with the Office of Management & Budget, Finance Department, and the City Attorney's Office.
