SUMMARY AND RECOMMENDATIONS

This ordinance accepts the lowest responsive bid, appropriates funds, and awards a construction contract in the amount of \$247,292.55 payable to San Antonio Constructors, Ltd., authorizes \$21,291.33 for Project Contingency, authorizes \$16,394.32 for Capital Administration Cost and \$2,000.00 for Advertising Expenses, for a total ordinance amount of \$286,978.20 in connection with the Hollyhock at Huebner Creek Drainage Structure project, an authorized 1994-1999 Drainage Improvement Bond and Storm Water Facilities funded project located in Council District 7. Of the \$247,292.55 amount, \$212,913.30 will be funded with City Funds and \$34,379.25 is funded by San Antonio Water System (SAWS).

Staff recommends the approval of this ordinance.

BACKGROUND INFORMATION

This project will provide for an improved low water crossing on Hollyhock at Huebner Creek between Strathaven and Babcock Road consisting of the installation of concrete culverts beneath the roadway and minor channel improvements. Project construction is anticipated to begin in April 2006 and to be completed by August 2006.

This project was advertised for construction bids in the <u>Commercial Recorder</u>, the <u>San Antonio Informer</u>, and <u>La Prensa</u> in December of 2005. In addition, the bid announcement was made on TVSA, through the Small Business Economic Development Advocacy (SBEDA) Office and Dodge Report. Plans were also available for review by potential bidders at the office of Brown Engineering, Co. located at 1000 Central Parkway N., San Antonio Texas 78232. Bids for this project were opened on January 4, 2006 and three (3) firms responded. Of these San Antonio Constructors, Ltd., submitted the lowest responsive bid. San Antonio Constructors, Ltd., currently has six (6) active contracts with the City in the amount of \$7,317,950.00. A matrix of the bid outcome is included herein as Attachment 2.

The Economic Development Department has reviewed and approved the Good Faith Effort Plan submitted by San Antonio Constructors, Ltd., and the contractor has committed that 36.30% of

the work provided under this contract shall be completed by a MBE firm and 1.17% will be completed by an AABE firm. The Memorandum from the Economic Development Department is included herein as Attachment 3.

POLICY ANALYSIS

Approval of this ordinance will be a continuation of City Council policy to complete previously approved 1994-1999 General Obligation Drainage Improvement Bond funded projects.

FISCAL IMPACT

This is a one-time capital improvement expenditure. Funds in the amount of \$252,598.95 are included in the FY 06-11 Capital Improvement Budget. Funds in the amount of \$252,598.95 are available from Storm Water Facilities and \$34,379.25 is available from SAWS funds and authorized payable and appropriated as follows:

\$247,292.55	payable to San Antonio Constructors, Ltd. for construction services
\$ 21,291.33	for Project Contingency
\$ 16,394.32	for Capital Administrative Cost
\$ 2,000.00	for Advertising Expenses

COORDINATION

This request for ordinance has been coordinated with the Office of Management and Budget and the Finance Department, the City Attorney's Office, and San Antonio Water System.

SUPPLEMENTARY COMMENTS

This construction contract was developed utilizing the formal competitive bid process; therefore, a Discretionary Contracts Disclosure Form is not required.


