#### **SUMMARY AND RECOMMENDATIONS**

This ordinance authorizes the City Manager to execute a five year lease agreement not to exceed \$316,750.00 with S & S Shopping Centers, Ltd. for office and clinic space for the San Antonio Metropolitan Health District's Women, Infants and Children Supplemental Nutrition Program (WIC) Clinic located at 3600 Fredericksburg Road for the period February 1, 2006 through January 31, 2011. This ordinance will also approve payments for said lease.

Staff recommends approval.

#### **BACKGROUND INFORMATION**

The Health District's WIC Program is a project funded through a grant from the Texas Department of State Health Services which provides nutritious foods and nutrition education to an estimated 48,000 individuals per month in twelve locations scattered throughout the City. The location at 3600 Fredericksburg Road, with 5,000 square feet of office and clinic space, was opened in 2001 and has been one of the busiest and most successful sites, serving an estimated 6,300 participants each month. Nevertheless, in anticipation of the need for a new lease, and in accordance with Texas Department of State Health Services guidelines, an announcement was printed in the San Antonio Express-News on November 15, 16, and 17 of 2005, indicating SAMHD's need for space to house the WIC Clinic on the Northwest Side. S & Shopping Centers Ltd, the current landlord, was the sole respondent and provided an offer at the current rental rate.

In view of the documented success of the program at this location and the willingness of the landlord to provide this facility at a reasonable rate, staff recommends acceptance of the proposed lease agreement.

# **POLICY ANALYSIS**

This ordinance follows past City policy in utilizing leased space to augment City-owned facilities.

# FISCAL IMPACT

This lease agreement is for the period February 1, 2006 through January 31, 2011 at a flat rate of \$5,000.00 per month plus common area maintenance (CAM) charges calculated at \$0.67 per square foot per year (\$279.16 per month). With CAM charges the monthly rent is \$5,279.16 or \$1.06/square foot. The total cost of the five-year lease will not exceed \$316,750.00 and will be entirely supported through grant funding.

## **COORDINATION**

The City Attorney's Office, the Human Resources Department, Risk Management Division, and Asset Management have reviewed and approved the lease agreement with S & S Shopping Centers, Ltd. This ordinance has been coordinated with the Office of Management and Budget and the Finance Department.
