Staff Recommendation: Inconsistent. The Neighborhood Plan currently has a future land use designation of Public / Institutuional. An amendment to Neighborhood Commercial was heard by the Planning Commission on January 25, 2006 and they recommended approval. The request will go forward to City Council on March 9, 2006. Approval pending land use plan amendment. The subject property is at the intersection of two major thoroughfares. Both Clark Avenue and Hot Wells are Secondary Arterials Type B. The property to the east, west, and north are all zoned commercial. C1 commercial uses are low intensity and can be compatible with nearby residential uses.
