SUMMARY AND RECOMMENDATIONS

This ordinance approves the renewal of two Farmer's Market Plaza Lease Agreements with Mr. David Kirby d/b/a "Fresh Concepts" for Stall S-15 and Ms. Lisa Rodriguez d/b/a "Baptismal Boutique" for Stall S-10, in City Council District 1.

Staff recommends approval of this ordinance.

BACKGROUND INFORMATION

Following renovations to the Farmer's Market Plaza Stall Store lease areas, on March 4, 2004, City Council passed Ordinance No. 98919 authorizing Lease Agreements with twenty-three (23) tenants with terms of five years and six months (5 ½ years). Through this same ordinance, lease agreements were also authorized with "Fresh Concepts" and "Baptismal Boutique" who were then placed on probationary status as a result of previous delinquencies. These probationary lease terms have now expired and these tenants are now eligible to renew under the original lease terms as established by Ordinance No. 98919. "Fresh Concepts" and "Baptismal Boutique" have remained current on rent payments to the City.

This ordinance would approve renewal of these Lease Agreements, to be effective April 1, 2006 through August 31, 2009 to coincide with the expiration date of the other 23 stall tenants in the Farmer's Market Plaza.

POLICY ANALYSIS

It is the long-standing policy of the City of San Antonio to lease public property in the Farmer's Market Plaza for retail sales purposes under regulations established in Chapter 32, Article II of the City Code of the City of San Antonio. The renewal of these leases is consistent with the probationary provisions approved by City Council through Ordinance No. 99477.

FISCAL IMPACT

As per the rental rate schedule established by Ordinance No. 98919, March 4, 2004, the following will be the rent payments for "Fresh Concepts" (a half stall) and "Baptismal Boutique" (a full stall):
