

Please provide a brief narrative outlining your reasons for seeking appointment to a board or commission. (Resume or additional information may be attached.)

I would like to serve on the Disability Access Advisory Committee for many reasons. As the father of a severely handicapped child, I understand the need for accessible routes along the city streets and within establishments. There have been many times that had I not been able to physically carry my child and his wheelchair, he would have been denied access. This does not seem fair.

As an engineer and Registered Accessibility Specialist, I also understand the costs and difficulties associated with making all routes and establishments accessible. Many times, there are no good solutions that satisfy all design criteria. In these cases, I rely on my engineering skills and my knowledge as the father of a handicapped child to design the best option.

I feel this experience makes me qualified for this committee.

Finally, I would like to use my experience and knowledge in the accessibility area to make San Antonio a friendlier city to the disabled. This is good for the City with respect to the citizens as well as tourists. As with anything that has an impact on a person, people remember places that are easy to maneuver within, as well as those that are difficult.

Richard N. Berry is a licensed professional engineer with 20 years of experience. In the past, Mr. Berry has instructed environmental and public works issues for The Texas Engineering Extension Service, with duties including the development of curriculum and presentation of technical data to a variety of students. Currently, Mr. Berry provides consulting engineering services to public and private sector clients. These services include engineering design of above and underground fuel storage as well as other civil and environmental engineering projects.

The previous twelve years experience has been associated primarily with environmental engineering, fuel system designs, and remediation of soil and ground water contamination. Duties have included construction management for the installation of numerous ground water treatment facilities throughout the State, and remediation of hydrocarbon contaminated facilities over the Edwards Aquifer Recharge Zone.
