SUMMARY & RECOMMENDATION

This ordinance authorizes the Purchasing & General Services Department to accept the bid submitted by GTSI Corporation utilizing the U.S. Communities Contract to provide the City of San Antonio Fire Department with video teleconferencing components for the mobile command vehicle for a total of \$40,661.04 from the 2005 State Homeland Security Program. Staff recommends approval of this ordinance.

BACKGROUND INFORMATION

Submitted for council consideration and action is a bid from GTSI Corporation utilizing the U.S. Communities Contract to provide the City of San Antonio Fire Department with video teleconferencing components for a total of \$40,661.04.

On March 24, 2005 per Ordinance No. 100561, the City approved the purchase of one bus shell chassis for the Fire Department Fire Fighting Division. This bus shell chassis was converted into a regional mobile command vehicle which supplies support to the Fire Department's command needs for large-scale emergency incidents for the citizens of San Antonio, Bexar and Comal counties as well as the rest of the region.

The purchase of the video teleconferencing components will integrate and supplement existing video teleconferencing systems and provide teleconferencing capabilities from the command vehicle to the Emergency Operations Center. The video teleconferencing components will enable staff to view video emergencies, assess the emergencies, give feedback to staff and communicate with most local Police Department command centers, District Chief locations, and Bexar, Comal, and Guadalupe County Emergency Operation Centers during emergencies.

The video teleconferencing components will include audio and video which will effectively provide an additional communication method during an emergency. This purchase will allow staff at the Emergency Operations Center's to view and hear live footage and offer support to emergency situations.

POLICY ANALYSIS

In December 2005, per Ordinance No. 101755, the City of San Antonio accepted a grant from the U.S. Department of Homeland Security for homeland security readiness planning, training and equipment. The State Homeland Security Program (SHSP) grant supports cooperative communication among multi-jurisdictional entities by teleconferencing via video during emergencies.

This purchase is made in accordance with the US Communities Cooperative Program, Contract No. RQ03-605674-16A, passed on Ordinance 98797 dated February 12, 2004 and will utilize the GTSI Corporation contract with Fairfax County as a lead agency.

FISCAL IMPACT

The total cost of this contract is \$40,661.04. Funding will be from with the 2005 State Homeland Security Program. All expenditures will be in accordance with the FY2005-2006 Budget approved by City Council.

COORDINATION

This item has been coordinated with the City of San Antonio Fire Department and the Information Technology Services Department.
