#### **SUMMARY AND RECOMMENDATIONS**

An ordinance authorizing the acceptance of a \$90,000.00 grant from the Texas Department of Transportation for the "Click It Or Ticket" Selective Enforcement Program's Seat Belt and Child Safety Seat enforcement program for the grant period May 22, 2006 to June 4, 2006.

Staff recommends approval.

#### **BACKGROUND INFORMATION**

The Texas Department of Transportation did not require agencies to apply for the "Click It Or Ticket" grant. Instead, grants were awarded by virtue of their prior years' activity and overall need based on their criteria. On April 3, 2006, the Texas Department of Transportation provided the San Antonio Police Department with the documentation and appropriate forms to accept the fifth year "Click It Or Ticket" grant for a seat belt and child safety seat enforcement program. This grant will fund overtime efforts to insure compliance with state laws requiring the use of seat belts and child safety seats for motor vehicle operators and passengers. The goal of this grant program is to increase the seat belt usage rate to 85% nationwide.

This grant will provide for the payment of overtime and administrative costs incurred during the grant period of May 22 through June 4, 2006. The first year's grant was for \$145,000, the second year's grant was for \$185,000, the third year was for \$82,486 and the fourth year grant was for \$90,000.

#### **POLICY ANALYSIS**

This Ordinance continues City Council's policy of seeking intergovernmental financial assistance for City crime prevention and enforcement programs. The program from TxDOT will enhance the City's efforts in the enforcement of state traffic laws.

## **FISCAL IMPACT**

The program budget totals \$90,000 and does not require an in-kind or cash match.

## **COORDINATION**

This ordinance request has been coordinated with Finance, City Attorney's Office, and the Office of Management & Budget.
