#### **SUMMARY AND RECOMMENDATION**

An ordinance authorizing the purchase of Commercial Property Insurance, including Boiler and Machinery Coverage, for City-owned and leased buildings, contents, and equipment with Great American Insurance Company, through McGriff, Seibels & Williams of Texas, Inc., the City's broker of record, for a three (3) year period beginning February 28, 2006 with a first year premium at a cost of \$1,264,257, and a guaranteed premium rate of \$0.0666 (rounded) per \$100 of total insured value of property for the second and third years.

Staff recommends approval of this Ordinance.

#### **BACKGROUND INFORMATION**

The City advertised a Request for Insurance Quotes in the San Antonio Express News on December 16, 2005 and December 23, 2005, which solicited for Commercial Property Insurance, including Boiler and Machinery coverage. A notice of the solicitation was also placed on the COSA website. The City's Broker of Record also began marketing activities for this renewal coverage in November, 2005.

The City's Broker of Record approached six primary and two excess insurers to secure quotations for coverage at limits adequate to protect the City's current insurable values estimated at \$1,898,514,170. A total of six quotations were received. The bid specifications provided for at least a \$500,000,000 loss limit, with separate underlying limits for specific coverages needed by the City; most notably, Business Income and Extra Expense for the Convention Center and the Alamodome, Electronic Data Processing (EDP) Equipment and Media, Mobile Equipment, Automobile Catastrophe Physical Damage, Fine Arts, Flood and Earthquake. Of the six quotations received, one quotation from TML (Texas Municipal League Intergovernmental Pool) was rejected because they only offered a \$5,000,000 loss limit.

The premium quote from Great American Insurance Company and its participating excess insurers provided the ability to insure the City's total insured values (estimated at \$1.898 billion) with a \$250,000 deductible per-occurrence and includes coverage for acts of terrorism.

The program will be structured by Great American Insurance Company and its excess insurers to provide full coverage for the total insured value of each City owned building except for the Convention Center and the Alamodome. For these two buildings, Great American will provide layered coverage. Layered coverage allows insurance carriers to share the risk of possible loss.

The layered will be structured as follows: Great American will provide the first layer of coverage totaling \$200,000,000 (\$100,000,000 for each building). The second layer is a total combined amount of \$150,000,000 and will be provided by Columbia Casualty at \$100,000,000 and Arch Specialty at \$50,000,000. The third layer provides an additional \$156,000,000 underwritten by Landmark American. The total loss limits for all layers equals \$506,000,000 for the Convention Center and the Alamodome. Loss recoveries under the proposed program will continue to be paid on a replacement cost basis for both buildings and contents up to agreed values stated within the City's insurance schedule.

Great American and its excess insurers have agreed to guarantee a rate of \$0.0666 (rounded) per \$100 of insured value contingent upon the City's low probability of catastrophic loss and our existing low loss ratio.

Significant features of insurance coverage and some underlying limits or extensions include:

- Acts of terrorism are included up to the \$1,898,514,170 loss limit;
- \$100,000,000 limit for boiler and machinery direct physical damage;
- \$5,000,000 limit for debris removal;
- Coverage extension to newly acquired property for 90 days up to \$10,000,000;
- \$25,000,000 for flood and water damage for locations not zoned for "100 year floods";
- \$5,000,000 for flood and water damage for properties in "100 year flood zones";
- \$25,000,000 per occurrence limit for earthquake;
- \$40,000,000 limit on EDP Equipment and Media;
- \$10,000,000 limit on business income and extra expense for the Convention Center and the Alamodome;
- \$10,000,000 limit for scheduled fine arts;
- \$5,000,000 limit for inadvertent errors and omissions on the part of the City;
- \$3,500,000 limit for mobile ("Contractors") equipment; and,
- \$1,000,000 limit for Service Interruption property damage and time element

McGriff, Seibels & Williams of Texas, Inc., the City's Broker of Record, recommends placing the City's property coverage with Great American Insurance Company for the next three years. Based upon current estimated total insured values of \$1,898,514,170, the annual premium for the first year of this coverage is \$1,264,257.

#### **POLICY ANALYSIS**

This action is in keeping with the City's past practice of purchasing commercial property insurance to protect the City's assets in the event of large physical damage or business interruption losses. The Risk Management Division concurs with McGriff, Seibels, & Williams of Texas' recommendation. This policy benefits the City by locking-in a lower three year guaranteed rate and includes the total insured values as compared to last year's 14-month

policy rate of \$0.0725 per \$100 of total insured value and a considerably lower loss limit of \$500,000,000.

#### FISCAL IMPACT

Sufficient funds have been budgeted in the Liability Self-Insurance Fund for the first year policy premium. The second and third year premiums will be contingent upon subsequent funding as approved by City Council.

#### **COORDINATION**

This item has been coordinated with Finance, Office of Management and Budget, and the City Attorney's Office.
