#### **SUMMARY & RECOMMENDATION**

This ordinance authorizes the Purchasing & General Services Department to accept the low bid submitted by BWI Schulenburg to provide the City of San Antonio Parks & Recreation Department with fertilizer for a total of \$79,236.00 from the Golf Special Revenue Fund. Staff recommends approval of this ordinance.

#### **BACKGROUND INFORMATION**

A request for sealed bids was issued to purchase fertilizer for the City of San Antonio Parks & Recreation Department. A total of three bids were received. The low bid was submitted by BWI Schulenburg for a total \$79,236.00. This bid was advertised in the Daily Commercial Recorder, La Prensa, the San Antonio Observer, the City of San Antonio Purchasing Website, Public Access Channel 21 and Demandstar.com.

This contract will provide the City of San Antonio Parks and Recreation Department with a contractor to supply and provide customized application of 111.6 tons of bulk fertilizer utilized for the annual fertilization of the City golf courses and driving ranges. The application of the fertilizer will begin in late February 2006 and run through September 30, 2006.

#### **POLICY ANALYSIS**

Annually, the City of San Antonio Parks and Recreation Department Golf Course Operations requests the services of a contractor to supply and apply bulk fertilizer needed to maintain the golf courses. These services are required as part of their annual maintenance program. The contractor will provide labor, equipment and fertilizer necessary to complete the application. The purchase is estimated to last through September 30, 2006.

#### **FISCAL IMPACT**

The total cost of this contract is \$79,236.00. The funding will be from the Golf Special Revenue Fund. All expenditures will be in accordance with the FY2005-2006 Budget approved by City Council.

#### **COORDINATION**

This ordinance has been coordinated with the City of San Antonio Parks and Recreation Department.
