SUMMARY AND RECOMMENDATIONS

An ordinance authorizing the City Manager or her designee to execute an agreement with the Texas Department of Transportation (TxDOT) and providing that TxDOT will reimburse the City, in an amount not to exceed \$466,845.00 for the cost of furnishing and installing of traffic signal equipment at various locations on IH 10, IH 35, IH 37 and IH 410 frontage roads. Funds in the amount of \$466,845.00 will be funded from the Traffic Operations General Fund and will be reimbursed by TxDOT.

Staff recommends approval of this ordinance.

BACKGROUND INFORMATION

TxDOT is funding improvement projects on interstate highway frontage roads within the City of San Antonio. In order to ensure compatibility with the City's existing traffic signal system, the Public Works Traffic Operations staff will be responsible for the acquisition and installation of traffic signal equipment for these locations and TxDOT will reimburse the City for these costs. Included in these projects is the installation of new traffic signals or reconstruction of existing traffic signals at the following locations:

IH 410 – From East of Broadway to Beitel Creek (Install new signals)	Council District

POLICY ANALYSIS

Approval of this ordinance will be a continuation of City Council policy to collaborate with other governmental agencies in the development and construction of City infrastructure and to upgrade traffic signals, as funds are made available.

FISCAL IMPACT

Funds in the amount of \$466,845.00 will be funded from the Traffic Operations General Fund. The agreement requires the Texas Department of Transportation to reimburse the City of San Antonio an amount not to exceed \$466,845.00 for expenses incurred in purchasing and installing the traffic signal equipment needed at the intersections listed above.

COORDINATION

This request for ordinance has been coordinated with the Office of Management and Budget, the Finance Department, and TxDOT.
