SUMMARY AND RECOMMENDATIONS

An Ordinance declaring property as surplus and authorizing the sale to the Texas Department of Transportation of an approximately 3,777 square foot section of park land near the intersection of Quill Drive and Bandera Road, District 7, NCB 8356, as part of the expansion of Spur 421 (Culebra and Bandera Roads), for \$20,610.

Staff recommends approval of this Ordinance.

BACKGROUND INFORMATION

Petitioner is requesting to declare surplus to the needs of the City of San Antonio a 3,777 square foot parcel of land located at Bandera Road and Quill Drive as shown on attached Exhibits "A" & "B." This parcel is part of a small neighborhood park, which TxDOT requires for the expansion and development of Spur 421 (Culebra and Bandera Roads).

POLICY ANALYSIS

This action is consistent with the City Code and Ordinances, which require City Council approval for the disposition of any surplus City-owned real property.

FISCAL IMPACT

The City will collect \$20,610.00 for the sale of this property.

COORDINATION

In compliance with City procedures, this request has been canvassed through interested City departments, public utilities and applicable agencies. A Canvassing Checklist is attached for review.

SUPPLEMENTARY COMMENTS




