SUMMARY AND RECOMMENDATIONS

This ordinance authorizes the execution of a HUD 108 Funding Agreement with the Young Men's Christian Association of Greater San Antonio and the Hill Country (YMCA) for the expenditure of up to \$1,055,320.00 from the U. S. Department of Housing and Urban Development (HUD) under Title 1 of the Housing and Community Development Act to fund the replacement of the roof and to repair and/or replace certain portions of the building that have sustained damage associated with the roof leakage, renovate lobby, upgrade entrance, enlarge the wellness center, and add an aerobics room at the Davis Scott YMCA facility, located in Council District 2.

Staff recommends approval of this ordinance.

BACKGROUND INFORMATION

The City Council adopted a Capital Improvements Budget for HUD 108 funds, pursuant to Ordinance No. 100362, dated January 27, 2005. This budget includes \$555,320.00 allocated to improvements for the Davis Scott YMCA and an additional \$500,000.00 from a cancelled District Two project. A total of \$1,055,320.00 will be used for improvements including replacing the roof, repairing and/or replacing certain portions of the building that have sustained damage associated with the roof leakage, renovating lobby, upgrading entrance, enlarging the wellness center, and adding an aerobics room at the Davis Scott YMCA. The City Council designated the Department of Housing and Community Development as the City department responsible for the administration and monitoring of the project.

The Department of Housing and Community Development entered into an Interdepartmental Agreement with the Department of Parks and Recreation. Per the Agreement, the Parks and Recreation Department will implement and manage this project.

The HUD 108 funds may be utilized for design, renovation and construction, and building materials associated with these improvements. The YMCA will accept full responsibility to manage and provide all of the activities, services, and documentation necessary to satisfactorily complete the project.

POLICY ANALYSIS

This agreement is consistent with the City's policy to enter into agreements with other public or non-profit entities to assist with projects that benefit the citizens of San Antonio.

FISCAL IMPACT

The use of HUD 108 monies in the amount of \$1,055,320.00 was approved by City Council on January 27, 2005. Funds will be expended on a reimbursement basis with the project to be completed on or before September 30, 2011.

COORDINATION

This item has been coordinated with the City Attorney's Office and the Department of Housing and Community Development.
