**SUMMARY AND RECOMMENDATIONS**

This ordinance names the softball field, located in Cuellar Park at 5626 San Fernando in City Council District 6, as the "Rudy Perez Sr. Softball Field."

Staff recommends approval of this ordinance.

**BACKGROUND INFORMATION**

Councilwoman Delicia Herrera, City Councilwoman for District 6, submitted a request to the City Clerk's Office dated March 13, 2006 for the naming of the softball field at Cuellar Park at 5626 San Fernando to the "Rudy Perez Sr. Softball Field." The request was submitted to honor Mr. Rudy Perez Sr., a distinguished member of the community. He has served tirelessly to the Edgewood Pony League for many years.

As per the requirements of Chapter 2, Article VI of the City Code of the City of San Antonio, a committee was established to hold a public hearing on this proposal. The committee consisted of Councilwoman Delicia Herrera, City Councilwoman for District 6; Ms. Aurora Barrera, Community Representative; and Mike Gonzaba, Assistant Director of the Department of Parks and Recreation. In addition, as required by City Code, notice of the public hearing was posted and by direct notification of all residents and businesses within 200 feet of this public property.

Following the distribution of notices, there were four notices received in favor of the proposed name. The public hearing was held on Tuesday, May 23, 2006 at 6:00 p.m. at the Cuellar Community Center, located at 5626 San Fernando. Three members of the community attended the hearing. The committee concurred to recommend to the City Council that the softball field in Cuellar Park be named to "Rudy Perez Sr. Softball Field."

**POLICY ANALYSIS**



The naming and renaming of the City's public facilities is regulated under Chapter 2, Article VI of the City Code. This action is consistent with these regulations.


