SUMMARY

Councilwoman Patti Radle has requested council consideration of an ordinance to reprogram District 5 One Time Project Funds.

BACKGROUND

Previously in years 1999, 2000 and 2001 City Council authorized the allocation of One Time Project Funds for each council district during the budget process. These funds were appropriated to various projects identified by former council members such as speed humps, sidewalk repairs or traffic signals. When these projects have been completed, savings have been reallocated to new projects at the discretion of the council member and upon approval by ordinance. As required by state law, funding of these projects meet a public purpose which benefits the community at large.

FISCAL ANALYSIS

The Council District 5 One Time Project Fund allocation for the Inman Christian Center Corridor Revitalization has savings of \$23,783.87. A total amount of \$9,162 has been requested to be reprogrammed for projects at Holy Cross High School, Farias Park and the Plaza at Avenida Guadalupe and sufficient funds exist.

This ordinance request has been coordinated with Councilwoman Patti Radle and the Office of Management and Budget, City Attorney's Office, Parks and Recreation and Fire Department.
